Summary of Changes: Together 2 Goal[®] Campaign Measurement Specifications

Five updates to the T2G Measure Specs for the campaign extension, beginning April 2019:

- **1.** Extended for 2 years the table of measurement periods and reporting dates. Same quarterly data reporting schedule. See table below.
- 2. An optional change in how patients are qualified for the Active Initial Population (denominator for prevalence of type 2 diabetes) and the T2G Cohort (numerator for prevalence): 1 of the required 2 or more encounters (during the 18 months prior to the end of the 12-month measurement period) may now be a telehealth visit; and a type 2 diabetes diagnosis on an eligible telehealth encounter can be used to meet the inclusion criteria for the T2G cohort. For the telehealth encounters, we've added CPT codes to Table 1, and the HEDIS Value Set: Telehealth which includes CPT modifiers and CMS place-of-service (POS) code. See notes 2 and 4 in measure specifications.
- 3. Updated NCQA HEDIS value sets: HEDIS Value Sets for T2G Measures v3.0.xlsx.
- 4. Added CPT code 96160 to Table 1 (see table note for Table 1).
- **5.** Added two new medications to Table 6, ACE inhibitors and ARBs: amlodipine-perindopril (Prestalia) and sacubitril-valsartan (Entresto).

We remain grateful to NCQA for permission to use the HEDIS value sets and to base the T2G campaign measures on the HEDIS measures of Comprehensive Diabetes Care (CDC) and Statin Therapy for Patients with Diabetes (SPD). None of the measures for the AMGA Foundation Together 2 Goal campaign has been validated by NCQA. NCQA specifications are provided in Together 2 Goal for reference only and are not an indication of measure validity.
